Definitions

The terms "Myantiquesmarket.com", "sites", "site", "portal", "Name of the Trading Company", "we", "the company" represent the trading company MY ANTIQUES MARKET SRL and its services provided through the site Myantiquesmarket.com, a company with registered office in Municipiul Oltenita, 39 Argesului st., Romania, and registered with the Trade Register under no. J51/121/03.04.2012, tax number 30025392.

By the term "User" we understand all natural and/or legal persons that access the site Myantiquesmarket.com, irrespective of the reason.

The terms "Regulation", "Agreement", "Contract", "Terms and Conditions" are used to designate this use contract.

Acceptance of the use agreement

This agreement applies to the site Myantiquesmarket.com, its services and its content. By creating an account on the site Myantiquesmarket.com, the system will generate a profile which may be accessed on the site, but may be deactivated by using the corresponding options.

The sites, services and content of Myantiquesmarket.com are offered depending on your acceptance without any change of the conditions in this agreement. Confidentiality policy
